

# 2012 TOURNAMENT CONTRACT CONFIRMATION

We would like to thank you for choosing The Courses at Hyland Hills as your tournament site. We will be happy to supply score sheets, longest drive, closest to the pin flags, customized score sheets and rules, personalized player thank you packs, food and beverage packs, meeting space and much more to make your tournament a success.

Full 18 hole shotgun events require a minimum guarantee of 124 players and are limited to a total of 154 players .

9 hole shotgun events require a minimum guarantee of 52 players and are limited to a total of 72 players. Partial field shotgun starts are also available, reverse shotgun starts, as approved by the Director of Golf.

All other tournament events will be reserved tee times.

18 Hole tournament fees of \$68.00/player include full green fees, electric cart rental, driving range token, and \$12.00 credit for merchandise prizes or gift certificates redeemable only at the Golf Shop and require a non-refundable deposit of \$200.00, payable upon contract signing.

9 Hole tournament fees of \$34.00/player include full green fees, electric cart rental, and \$6.00 credit for merchandise prizes or gift certificates redeemable only at the Golf Shop and require a non-refundable deposit of \$100.00, payable upon contract signing.

The above referenced non-refundable deposit, together with this signed Agreement, must be received by The Courses at Hyland Hills in order to reserve the date you have requested and that has been approved by us. Your deposit will be applied towards your final tournament fees. If you cancel the tournament for any reason, your deposit will be forfeited.

Full tournament fees (based on a minimum guarantee not less than the stated Course minimums) must be paid by the Tournament Sponsor not less than fourteen (14) days prior to the tournament date. Fees for additional players must be paid the day of the tournament. If the payment of and monies payable under the terms of this Agreement shall not be paid when due, a late payment charge equivalent to ten percent (10%) of the amount, which remains late and unpaid, shall be added to the total tournament fee. Refunds will not be issued for a lower number of players on the contract unless the Director of Golf is notified 14 days prior to the event.

As a reminder, listed below are some of the policies which must be followed:

(1) A list of players must be provided in the order of tee times or hole assignments, no later than, 3 days before the tournament.

(2) No outside alcoholic beverages, food, drink or coolers are allowed on the premises: this includes bottled water for carts. Customized food and beverage packages are available through Ciancio's at Hyland Hills Restaurant and Lounge and The Golf Courses at Hyland Hills.

(3) All players must be reminded that playing time per nine holes is two hours, fifteen minutes or less. The Golf Shop staff and players assistants are in charge of pace of play and can remove players for any just cause from the golf course and no refund will be given.

(4) PGA professional golf instruction clinics are available upon request. Please contact the Golf Shop for details.

(5) All players are responsible for any damage they cause. We reserve the right to collect a damage deposit in advance of the scheduled tournament.

(6) Due to the difficulty of our Gold Course, playing the white tees is recommended.

(7) Hyland Hills has a mandatory soft spike program in effect. Tennis shoes are also allowed.

(8) Upon completion of play please return carts to the cart barn.

(9) If, in the sole judgment of Hyland Hills, The Courses are unplayable due to inclement weather or other catastrophe, the tournament director shall have the option of applying the tournament fee paid to Hyland Hills to a future tournament date or refunded after deducting any fees for food or drink consumed by tournament participants.

(10) Our clubhouse facilities are open for breakfast, lunch, and dinner. We also provide banquet facilities for 20 to 200 guests and continental breakfast, box lunches and patio parties for tournaments. For arrangements, please call Cianco's at Hyland Hills Restaurant and Lounge at (303) 657-8870.
