Full 18 hole shotgun events require a minimum guarantee of 124 players and are limited to a total of 152 players. Partial field shotgun starts are also available with reverse shotgun starts, as approved by the General Manager.

9 hole shotgun events require a minimum guarantee of 52 players and are limited to a total of 72 players. Partial field shotgun starts are also available, reverse shotgun starts, as approved by the General Manager. All other tournament events will be reserved tee times.

18 Hole Tournament fees:

M-TH \$83/player *10% discount for non-profit tournaments M-Th only F-SU \$85/player

Tournament fees include green fees, electric cart rental, driving range token, and \$12.00 credit for merchandise prizes or gift certificates redeemable only at the Golf Shop and require a non-refundable deposit of \$200.00, payable upon contract signing. Additional carts for vendors/volunteers can be rented for \$36 ea.

9 Hole Blue Course Tournament fees:

\$42/player *10% discount for non-profit tournaments

Tournament fees include green fees, electric cart rental, and \$6.00 credit for merchandise prizes or gift certificates redeemable only at the Golf Shop and require a non-refundable deposit of \$100.00, payable upon contract signing. Additional carts for vendors/volunteers can be rented for \$18 ea.

9 Hole South Par 3 Course Tournament fees:

\$28/player *10% discount for non-profit tournaments

Tournament fees include green fees, electric cart rental, and \$6.00 credit for merchandise prizes or gift certificates redeemable only at the Golf Shop and require a non-refundable deposit of \$100.00, payable upon contract signing. Additional carts for vendors/volunteers can be rented for \$18 ea.

Tournament deposits will be returned through the accounting department and usually take 2-3 weeks to process.

The above referenced non-refundable deposit, together with this signed Agreement, must be received by The Greg Mastriona Golf Courses at Hyland Hills to reserve the date you have requested and that has been approved by us. Your deposit will be applied towards your final tournament fees. If you cancel the tournament for any reason, your deposit will be forfeited.

Full tournament fees (based on a minimum guarantee not less than the stated Course minimums) must be paid by the Tournament Sponsor not less than fourteen (14) days prior to the tournament date. Fees for additional players must be paid the day of the tournament. If the payment of and monies payable under the terms of this Agreement shall not be paid when due, a late payment charge equivalent to ten percent (10%) of the amount, which remains late and unpaid, shall be added to the total tournament fee. Refunds will not be issued for a lower number of players on the contract unless the General Manager is notified 14 days prior to the event.

As a reminder, listed below are some of the policies which must be followed:

(1) A detailed list of players names with pairings must be provided no later than, **10 days** before the tournament (tournaments that are not full field require a player total **10 days** prior to the event). (2)

Outside Alcohol Is Not Permitted Under the Public Consumption Section of the Colorado Liquor Code 44-3-901(I). Alcohol Brought on the Premises Will Be Confiscated and Violators May Be Prosecuted

No outside alcoholic beverages, food, drink or coolers are allowed on the premises: this includes bottled water for carts. Customized food and beverage packages are available through The Hyland Hills Restaurant and Lounge and The Golf Courses at Hyland Hills.

- (3) All players must be reminded that playing time per nine holes is two hours, fifteen minutes or less. The Golf Shop staff and players assistants are in charge of pace of play and can remove players for any just cause from the golf course and no refund will be given.
- (4) PGA professional golf instruction clinics are available upon request. Please contact the Golf Shop for details.
- (5) All players are responsible for any damage they cause to the golf course property or carts. We reserve the right to collect a damage deposit in advance of the scheduled tournament.
- (6) Due to the difficulty of our Gold Course, playing the white tees is recommended.
- (7) Hyland Hills has a mandatory soft spike program in effect. Tennis shoes are also allowed.
- (8) No more than 2 persons and 2 bags are allowed in golf cart. Drivers of golf cart must be 16 years of age and possess a valid driver's license. Upon completion of play please return carts to the cart barn.
- (9) If, in the sole judgment of Hyland Hills, The Courses are unplayable due to inclement weather or other catastrophe, the tournament director shall have the option of applying the tournament fee paid to Hyland Hills to a future tournament date or refunded after deducting any fees for food or drink consumed by tournament participants.
- (10) Our clubhouse facilities are open for breakfast, lunch, and dinner. We also provide banquet facilities for 20 to 200 guests and continental breakfast, box lunches and patio parties for tournaments. For arrangements, please call the Hyland Hills Restaurant and Lounge at (303) 657-8870.
